Information We Collect

We may collect two main types of information:

Personal Information: Details that identify you, including:

- Name, email, phone number, and address
- Business contact info
- Project-related communication
- Job application details
- · Survey feedback or contact form submissions
- IP address or device info

Non-Personal Information: This includes technical data such as:

- Browser type, device, operating system
- Website usage patterns
- Data from cookies or analytics tools
- Aggregated or de-identified data

We do **not** knowingly collect Sensitive Personal Information (like social security numbers or health records).

How We Collect It

We collect information when you:

- Fill out a form on our website
- Contact us by phone, email, or in person
- Subscribe to newsletters or attend events
- Apply for a job
- Use our website (via cookies, analytics, or tracking pixels)



We may also receive information from trusted partners, event co-hosts, or publicly available sources.

How We Use Your Information

We use the information we collect to:

- Communicate with you about projects or services
- Deliver and manage our services as Owner's Representatives, Construction Managers, or Development Partners
- Respond to inquiries, feedback, or requests
- Improve our website and marketing efforts
- Comply with legal obligations
- Share company updates, event invitations, or newsletters (with your consent)

We may share information with:

- Government or legal authorities when required by law

Our website may use cookies or tracking tools (like Google Analytics or Facebook Pixel) to help us understand how visitors use our site. You can manage your cookie settings through your browser.

Data Security
